1 Lay Vice-Chairperson's Report

1.1 Introduction

In September 2017 we saw the departure of the Rev. Peter Ashman as he left to become the Rector of St. John the Baptist, Weston-super-Mare the following month. Thus began 'The Vacancy' or as it was once called 'the Interregnum'. The role of the PCC remains the same during the 'vacancy' but the lay vice chairperson takes over from the rector in making sure that the PCC fulfils its role.

1.2 Thanks and support

I am indebted for the help and support that has been given to me by Vanessa Bevan our PCC Secretary and Geraldine Dennis our Churchwarden. Between them their experience has enabled us to remain 'on track' and we have been able to do all the things that are required of us. The PCC has had a standing committee meeting that has met prior to each of the PCC's meetings in August 2017, January and March 2018.

I would like to thank all PCC members who have continued to carry out their specific roles in a conscientious way. We had additional meetings in October and November 2017 as PCC members were very keen to discuss amongst themselves and with our congregation, the qualities we want from the new rector. This hard-work was rewarded as our documentation was very helpful when we met to discuss the priest's profile with the other PCCs in the Beacon Mission Community and with the Archdeacon and the Bishop of Plymouth.

I would like to thank our new treasurer Phill Harvey for working with us and keeping our church balances healthy. I would like to acknowledge the time and effort Roger Chamberlain has given in helping Phill and the church wardens.

At St. Andrew's Church we have been doubly blessed because we have two Honorary Assistant Priests. The Rev. Tony Meek and the Rev. Anne Burden. Both of them have worked extremely hard by ensuring that our spiritual lives have been cared for, by taking our Sunday and week day services. They have taken church funerals and provided support and comfort to those whose loved ones have died. During the 'vacancy' we will have had at least one wedding and a baptism, again taken by our honorary assistant clergy.

1.3 700th Anniversary

On May 3rd 2018, we will, with the Rt. Rev. Robert Atwell, be celebrating the 700th Anniversary of the dedication of the high altar, which was performed by Bishop Walter Stapledon on May 3rd 1318. Bishop Robert will during a sung Eucharist, re-dedicate the altar in the chancel, which now has five incised crosses on it, just like the original stone altar that Bishop Stapledon dedicated. Bishop Robert will bless also a wall hanging depicting scenes from the village. This has been made by a group of villagers in Ipplepen. The programme of events to mark the 700th Anniversary is to be found at the end of the Annual Report.

This exceptional anniversary has been achieved only by the love and dedication that the people of Ipplepen have given to the church building and to each other through the centuries. I would like to thank all our parishioners for their support over the years and in particular during the time of the 'vacancy' when people have taken on additional roles and responsibilities.

I commend this Annual report to you. I thank all our contributors and all those who are involved in our church.

2 Churchwardens' Report

2.1 Introduction

Every year is a busy year and this year has been busier than usual. In the month of August 2017 the Rev. Peter Ashman announced that he would be leaving the churches of the Beacon Mission Community and would take up the position of Rector in St. John the Baptist, Weston-super-Mare in October 2017. This was the official start of the 'vacancy' although the previous month we had to take over the organisation and running of the church.

This year our report attempts to highlight not just the roles and responsibilities of the churchwardens, including additional work caused by the 'vacancy', but to show that we are not able to do our job, nor the PCC fulfil its roles and responsibilities, without most members of the congregation taking on a particular role or roles. We endeavour to show case this and most importantly to thank individuals and groups of people for the work they do on a regular basis. Trying to thank people can be quite difficult as there is always the difficulty of missing out an individual person or group! However that is not a reason for not trying to recognise the work of everyone who helps. If you or your group are missed out, please do not be offended. We hope that our thank you to everyone involved in making St. Andrew's Church, a warm, friendly, inviting and comfortable church, will be sufficient.

2.2 Additional responsibilities

Our policy is to try and maintain the status quo during the 'vacancy'. The first and most important job has been to find clergy who are available to take the Sunday and week day services. For funerals, baptisms and weddings these events have required extra work, which Geraldine has undertaken, e.g. phone calls to undertakers, additional paperwork and meeting people, who under 'normal' circumstances, would have met the Rector.

Our responsibilities are increased during the 'vacancy', as we with the PCC are responsible for the church and church hall buildings. We meet people who come into either of the buildings to carry out general maintenance and repairs.

2.3 Church building

Our burden has been made lighter as we have been helped greatly by our two deputy churchwardens, Jane Outhwaite and Michael Price. They have taken on some of our duties when we have not been available as well as continuing with their own. Therefore we thank them for all their support. We rely on the expertise of Stephen Bryant with any aspect to do with the church building. We thank him for his hard work and the dedication he has for the building. We thank also John Tuckett and members of the working party who come each month to carry out repairs in and around the church and the grounds. So much of their work is unseen but vital to the protection of the church building. A special thank you must be given to Gordon Dennis who does many jobs to assist us in the church and hall.

We must also thank Shirley Northwood who as the 'booking/events secretary' of the church hall has worked very hard to promote it for hire so that most of the time the hall is being used. The revenue is used to pay bills for the church hall and the church.

2.4 Church grounds

Recently we have been very fortunate to have John Lynch who keeps the grass under control, and makes sure that the graveyard is kept tidy. John is helped by the work of our volunteers who help him cut the grass. Consequently the graveyard always looks very well kept and many people make positive comments. Each week John puts out the rubbish bins and when we have funerals and weddings, he sets out the bollards by the west lychgate. On March 1st when we experienced the blizzard, John ensured that the path from the lychgate to the church was gritted and he swept the snow away before and after the funeral service. We thank him for his work.

2.5 Those involved in preparing for our church services

Our church services have remained the same in number and high in quality during the 'vacancy' due to the wonderful work of the Revs. Anne and Tony. We are very grateful and thank them very much. They have taken most of the Sunday and week day services, funerals, weddings and baptisms. Madeleine has not had to find many other clergy to take services. We would like to thank the Rural Dean, Prebendary Alan White for taking some of the services and being on the end of the telephone to help us with queries.

We are grateful to Michael Price for arranging the programme of lay-led services, the speakers and creating a team of members from the congregation who lead these services. We thank those who are part of this team.

We thank also Jane Outhwaite for organising the readers for our Sunday services and all who are part of the team of readers. Also we are grateful to Jane for arranging the service of Compline during Lent and thank all those who prepare our prayers of intercession on Sunday.

Almost every Thursday afternoon, under the direction of Jo Innes-Lumsden, a small number of choir members meet and either Marilyn Ellis or Madeleine Fedrick come to play the organ for them during their practice of the hymns for the following Sunday's Parish Communion service. We would like to thank them for their steadfast loyalty and weekly commitment to help the congregation sing their praises to The Lord. We would like to mention and thank Tom Morris for his solo performances, his guitar playing and his support in the choir.

At this point we would like to thank Peter Gage for all his meticulous work in preparing the two altars, setting up the credence table and acting as server at our Parish Communion services. Without the support of Winnie Bryant and her team of Sacristans, whose numbers have been swelled by three new members, we would have to undertake the important jobs they do. This includes changing the altar frontal according to the feast days or season and taking home and laundering any linen used from the services. Thank you to all of you. Madeleine has continued to order all wine and hosts for use in all the Beacon Mission Churches as well as ordering candles and the annual orders of advent and paschal candles, ash and palms.

The smooth running of each service would not happen unless we had a team of reliable sides- people. Their role is very important as they are the first person someone will see as they come into the church for a service. The 'Welcome' helps everyone, including visitors who come into the church, to receive a smile, a hello and a hymn book etc. Their other jobs are to collect money during the Offertory hymn and then present it to the priest, where it is blessed. Later in the service they make sure that people who wish to receive Holy Communion go in an orderly manner and help those who need support stepping over the step in the Lady Chapel. We would like to thank them for doing these important tasks.

We have a team of hard working church cleaners who undertake the cleaning of what is a difficult space. As it is an old building, they have to battle against the dust and debris that falls down quite easily as well as the spiders that enjoy spinning their webs in all the difficult places to reach. We thank you for your work keeping the place clean and tidy. The congregation and visitors to the church appreciate your efforts.

What would our church look like if it was like Lent all year and there were no flowers? During Lent we miss having flowers so it is with great delight we see Sheila Stacey and her flower arrangers come in with armfuls of flowers and foliage to dress all the window cills and many other surfaces for Easter Sunday, Harvest and Christmas. During the rest of the year every week, one or two of the flower arrangers provide a flower arrangement. We thank them for their work and the joy their flower arrangements bring to the congregation.

2.6 Communication

The last group of people we would like to thank in our report are those who are involved in the important aspect of communication. Many thanks go to Richard Lumsden for designing and printing programmes and posters. When the Rector was here Richard printed all our service cards and more lately the pew leaflets which Madeleine produces.

We all enjoy receiving the Beacon Magazine and our grateful thanks go to Michael Price the editor and to Charles Quartley who prepares it for publishing and puts it on The Beacon Mission Community web site. Charles has also agreed to prepare for publishing this year's Annual Report.

During the 'vacancy' all the PCCs had to work together to provide a joint Beacon Parishes Community Profile. Charles very kindly agreed to set our profile text in a very professional and attractive format for us. Having received approval from the Bishop of Plymouth, the document was placed on the Diocese website so that prospective candidates who are looking for the position of Rector could read all about us. We would like to thank him for the time he spent on putting together this important document.

The remainder of the Annual Report has reports written from many other people who hold important roles or represent groups of people who work in our church. We would like to say a final thank you to them. As you read the report we hope you will see how complex an organisation this church is and that we rely on the kindness and generosity of so many volunteers.

3 Administration

3.1 Secretary's Report

We have had 3 PCC Standing Committee Meetings; 4 PCC meetings and 1 joint PCC meeting with those from the other parishes in the Beacon Mission Community since our APCM in 2017.

The joint PCC meeting was to discuss Legacies with Katie Stevenson from the Diocese as our speaker and a short talk by Steve Bassett our Health and Safety Officer. We now have leaflets in church concerning wills and our Treasurer has the Legacy packs.

We have also had a meeting to approve the use of online banking at St. Andrew's.

As we have been in a Vacancy since October we have had 4 meetings with the other parishes – one of them being with the Archdeacon – to discuss our way forward and the Parish Profile for approval. These have been smooth running and my thanks to all and especially Mick Sutherland-Cook for chairing these meetings. As you can see we have been very busy.

Needless to say, the churchwardens have had separate meetings and my thanks go to them for all their hard work. There is a lot for them to do during a Vacancy.

Finally my thanks go to all PCC members and Wardens for their support.

3.2 PCC Financial Report

The accounts for the year ended 31 December 2017 were approved by the PCC on 27 March 2018, having been independently reviewed by Malcolm Dando. The accounts are in section 7 below

GENERAL FUND

There was surplus from ordinary activities of £2,150, but overall a deficit of £10,098. This was mainly down to the General Funds contribution to the new boilers (total cost £15,833, of which £1,000 was paid from the Fabric Fund).

There was a reduction in Regular Giving through Yellow Envelopes, but it was more than compensated for by a general increase in collections. The Parish Giving Scheme continues to work very well.

There were no significant increases to general expenses to report, but as well as the new boiler expenses, there was a further £1,187 of extraordinary expenditure for a new lawnmower and church chairs. This was offset by extraordinary income of £4,772 being a legacy, various grants and the sale of a piano.

The General Fund Bank Account finished the year with a balance of £17,520 of which £2,136 relates to Restricted Funds. The General Deposit Account had a balance of £28,996.

The General Investments performed well in the year with their market value increasing by £8,600 to a total value of £108,239.

FABRIC FUND

The Fabric Fund showed a surplus of £1,744 with no major changes to Income or Expenditure, except for a £1,000 contribution toward the boiler. Once again, the major source of income was the Gift Day and tax recovered thereon via Gift Aid.

The balances at the year end showed £11,317 on the main account and £13,044 in the Deposit Account. The investments also performed well, increasing by £2,627 to a market value of £31,739.

3.3 Electoral Roll

The revision of the electoral roll will take place this year between 28th and 30th March.

However, at the time of writing, the position is as follows. At the beginning of the year there were 95 people on the electoral roll.

During the course of the year we were pleased to welcome one new member. Two members moved away and eight members have sadly died, which means that there are currently 86 people on the electoral roll.

4 The buildings

4.1 Fabric

There has been little change during the year and the building remains in good condition for its age.

The central heating system is now working well, but additional work needs to be done to the boiler house roof since the old flue was removed.

A new key safe has been installed in the vestry, bolted to the wall for security.

The north window cill of the belfry has been built up so that it now slopes outwards and rainwater runs to the outside. This work has been carried out, with help, by Colin Clark, Tower Captain.

Repairs to the window tracery are in hand and will commence in the spring of 2018.

As ever we are sincerely grateful to John Tuckett and others on the Working Party for the maintenance and repair work they carry out each month.

4.2 Bells, tower and ringers

We have had yet another busy year, ringing for every Sunday morning service, the maypole dancer's parade on Flower Show day, the Lantern procession in November and five weddings.

Our new learner, Lynda Gaunter, is progressing very quickly; she is now ringing for Sunday services. Two new, potential ringers recently came to have a try and they seem very interested.

The ringing chamber has been redecorated by the ringers, a new carpet has been laid, and it now looks very palatial. The old decor was looking somewhat tired.

The problem I mentioned in last year's report concerning the cill in the bell chamber, namely rain running down onto the bell frame causing corrosion has now been rectified by Mike Squire and myself, with concrete blocks and cement kindly donated by Jim Bruce. There are just a few finishing touches to complete the job.

We have ordered a new set of eight bell ropes, (due to be delivered shortly). In the past we have used flax/hemp ropes, which are affected by the weather causing them to shrink or stretch, so we decided to go for a pre stretched polyester type rope. These do not stretch or shrink with the weather but they are more expensive, £125 each for hemp, roughly £150 each for polyester. However they last at least three times longer. We were fortunate in kindly receiving a grant from the Ipplepen Community Fund for £1000 towards the cost of these.

The seventh bell has been getting harder to ring recently. There was definitely something wrong. Tony Clark, Mike Squire and I inspected and found that the bearings were badly worn. We purchased and fitted two new bearings. By undertaking the job ourselves we saved a considerable amount of money.

On the 27th January Andrew Vickery and I attended the Church of England Safeguarding Training Module for children and adults at risk.

4.3 Churchyard

The committee met informally at monthly Working Parties. During the year all headstones have been checked for safety and mounds levelled where possible.

The churchyard is nearly full and, apart from reserved grave spaces, room for future burials is very limited. During 2018 we will need to fence off part of the extension and lay out this new area for consecration.

We are grateful to John Lynch, who has maintained the churchyard to a high standard, and to the band of volunteers who have again helped cut the grass, and trim the laurel hedge. The working party also removed fallen debris from the trees each month, kept the gravelled area at the rear of the hall free from weeds and carried out repairs to the walls.

During the year an enthusiastic group of children from Ipplepen School once again worked hard in the churchyard removing weeds from the paths and stripping ivy from graves and trees. It was again a most enjoyable and happy event and much useful work was done. We are grateful to them and their teachers.

4.4 Church hall

I am pleased to report on another successful year for St. Andrew's Church Hall, in which the hall is being used every day of the week for either Church run events, or regular hirers for different classes such as yoga, pilates, fitness classes, Brownies, choir and band practices together with private parties and meetings. Church Luncheon Club and Messy Church are two other regular events.

This year I have taken on more regular hirers, which include Tai Chi lessons on Tuesday mornings and Spanish lessons for young children on Friday mornings. This all goes to prove what a great asset the hall is for the whole community.

Speaking of the community, following our application for a Co-op grant, I must say a big thank you to all parishioners who nominated our hall as their chosen charity. The Co-op gave 1% of all the monies spent on their own products throughout the year, and we were all certainly amazed when we were presented with a cheque for just over £1,400. This money will be used for new safety flooring and refurbishment work in the toilets and should hopefully be completed soon.

As always, I would like to thank all the hirers of the hall throughout the year. The monies raised help us to maintain the beautiful old building to such a high standard. My thanks also go to Geraldine and Madeleine for their support and to Jane who sets the heating in the winter months to keep my hirers warm. It has been my first year of working with our new Church Treasurer, Phill Harvey, who gladly accepts all the monies collected by me each month!

I look forward to continuing my work within the hall for the coming year.

6.3 Deanery Synod

The Rural Dean the Rev. Preb. Alan White presides over the Deanery Clergy and elected representatives. There were 3 meetings over the year:-

26th June 2017 here at St. Andrew's with a presentation by Peter Snook (street pastor)

19th October 2017 at Kingskerswell parish room and presentation by Charlie Pitman (safe guarding adviser)

15th January 2018 at St. Luke's Church, Milber, presentation by Rev. Preb. John Good, (one of the Bishop's Clergy officers)

Meetings close with Compline or the Lord's Prayer & Grace.

1) The main topic item for discussion and decision has been the Deanery financial situation, resources and expenses. The proposal was to charge parishes in our Deanery a % payment per parish/church, as adopted in other Deaneries. With this in mind and taking into account the re-organisation within our own Deanery. The standing committee after much careful discussion proposed to amend the sub-structure on a percentage of the common fund, and set an income figure of a £1,000 from the 5 Mission Communities. Each community will then decide how to split their contribution between the parishes.

2) The latest edition of the PCC Accountability Accounting Guide is being published and should now be available.

3) Safe-guarding – each parish is to up date

4) Health & Safety

It is with much sadness that after two years of agreed appointment time, the Rural Dean Rev. Preb. Alan White will stand down in May 2018, and he will be missed as he has served our Deanery with interest and dedication.

We have supported the local lantern parade, each class made their own large lantern and many of our children accompanied by their parents carried them in the parade.

As a school we have taken part in an Arts/History/RE week in association with the Ipplepen History Society. We used this week to support the 700th birthday of the Church. We have been and are very busy getting ready for this event.

At the end of the summer term Year 6 will again be involved with the community award and will be cleaning the church and clearing the grounds.

At school we always welcome visitors and would love to have members of the church come in to hear readers or read their favourite story.

Once the main course is cleared away, the children sit down with the guests and have ice-cream. Both young and old find plenty to chat about and it really is a win / win situation. At the end of the meal the children assist guests with coats and walking aids then help them out to the waiting cars. Not only that, they clear away tables and chairs and vacuum the carpet!

As ever, I am indebted to all members of our faithful team, and I value their commitment. In December I gave ten month's notice of my intention to stand down as co-ordinator. To date, no-one has beaten a path to my door pleading to take over the reins! It is my prayer that the Lunch Club will continue, as it means so very much to so very many.
