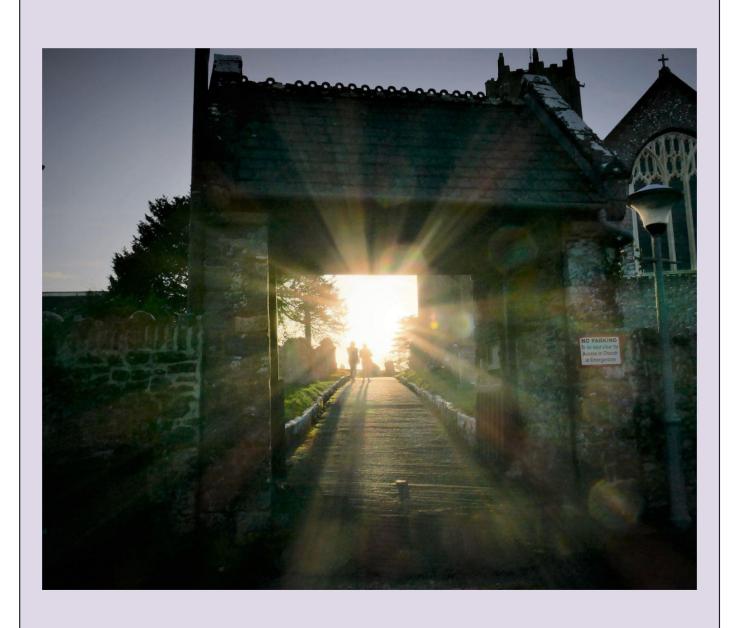

1 Rector's Report

Looking back on the last year we have focused, as a Beacon Parishes Mission Community, on developing wider opportunities for prayer and discipleship, and where we have been able to be of service to our communities.

Prayer and Worship

1. Morning prayer

- Location Zoom has continued once a week. The other days we continue the pattern of meeting physically while moving around our churches.
- Form of service we have tried to express the variety and breadth present in the Church of England and so we have Celtic Morning Prayer, Book of Common Prayer, Common Worship and silent meditation in different places across the week.
- Simplification The services have been simplified to allow space for sharing and reflection so building fellowship and discipleship amongst those who gather.

2. Sunday Worship

- Our pattern of celebrating the Eucharist has been established and continued. Every church has a Sunday Communion Service on alternate weeks.
- Broadhempston has developed a monthly service promoted to the wider community and families
- Ipplepen has developed a Joint Churches Together service
- Denbury has used Celtic Morning Prayer to vary from the set lectionary and explore other topics and themes with a variety of people in the community contributing.

3. Midweek Eucharist

 We have been keeping the Sunday lectionary readings in our weekly midweek Communion Services. This has enabled us to explore these readings more deeply. It has also has been appreciated by those who could not receive communion on a given Sunday.

4. Other services

 Occasional services continue to develop e.g. Compline now in Advent as well as Lent, Shoebox service, World Day of Prayer etc....

5. Festivals

 Trials of different forms of services have happened, particularly around Christmas and Easter, over the last few years responding to the needs and requirements of the pandemic. For example: combining Crib with Communion, and Carols with Christingle.

6. New services at Holy Trinity Torbryan

As well as Broadhempston's and Ipplepen's services mentioned above we have begun a bimonthly reflective Evening Prayer at Torbryan which is supported by that community and others from the surrounding villages. This year's theme has been celebrating the Saints.

Discipleship and Fellowship

Since the last APCM we have offered a variety of discipleship opportunities. We have tried to offer something every 2 months. So what have we done so far....

- 1. We have developed our Refresh, Revisit and Reflect course looking at the Christian way of life. This 6 session course has been delivered twice over the last year once on zoom and once physically and has been very well received. The course has been used to help a number of youngsters and adults prepare for their confirmation.
- 2. We have held a Living in Love and Faith course and from this provided feedback to the National Church.
- 3. We have had a book club style time where we read the book *Pheobe* by Paula Gooder with notes and prompts in the weekly notice sheet. It concluded, in June, with Paula Gooder joining us via zoom for a question and answer session.
- 4. During our midweek services of Morning Prayer and Communion we are creating spaces for greater reflection and sharing together
- 5. We put on an Advent Quiet Morning
- 6. We are currently running the Diocese Lent Course Surprised by generosity.

Service and Mission

- 1. Lunch club in Ipplepen has begun again and is growing and is very well supported.
- 2. We have had opportunities for a few of our usual fundraising and fellowship events. For example Denbury Christmas sale and harvest soup and Ipplepen's Christmas Fayre. Importantly the Christmas Fayre at St Andrew's was held in the church (rather than the village hall) and many who came said how they enjoyed and appreciated being in this space.
- 3. Concerts Trevor Ashford has begun a new venture of bringing music to the village of Ipplepen in aid of the church. These gatherings have been very successful. Concerts have begun again in Broadhempston church.
- 4. Bell project in Denbury. This is coming to a completion and many in the wider community have assisted not just financially but with practical support. A real community project and we look forward to its completion and the return of the bells.
- 5. Opening up our churches and making space for reflection. Our churches have continued to serve our communities as places of quiet prayer and reflection. At St. Andrew's a space has been made at the back which many have used and commented upon. We have also put posters displays up on occasion which have been very well received by those visiting our churches.
- 6. We have had the privilege of supporting many in our wider community through major life events through our ministry of Weddings, Baptisms and Funerals.

Looking forward it strikes me that the developments in prayer and discipleship need to continue and bed in. Now that restrictions have eased our main focus across the Beacon Mission Community needs to be on how we serve our communities building on the strong base we have in each of our communities.

2 Churchwardens' Report

Meanwhile services have continued in their regular pattern, which seems to be working well. Thank you to Andrew for this and to him, Rev'd. Anne, Rev'd. Tony and our Readers for their weekly Reflections. Our church life has been enriched by various courses, services such as Compline and at Torbryan church.

The Working party has continued their monthly sessions, keeping both the church and churchyard in excellent condition. The church architect who visited us this week, said that as soon as she walked into church she could feel that it was well cared for — a tribute to all those who work so hard to keep the church clean and well-maintained. Thank you to all of them and to John Lynch, who helps keep the grass cut. Thanks also to Geraldine who keeps all our various equipment up to date with testing and the appropriate certificates.

This past year we have revamped the post of Churchwarden, with six people sharing the task, although only two can be 'named' wardens for the bishop. Early days for the system, but thanks to them this has made life easier for the named ones — Clive Tompkins and myself — although both Geraldine and I will be stepping down this year. Anyone willing to share the load either as churchwarden or a member of the P.C.C. would be very welcome. It is a privilege to serve the church in this way and is very rewarding.

Finally, my grateful thanks to those who have served St. Andrew's so willingly by welcoming everyone into church; taking part in the service, whether playing music, reading or leading us in prayer; preparing the vestry; arranging flowers and the Pastoral Care Team for the valuable work they do. Not least, thank you to our dedicated team of bellringers who are so much appreciated by everyone. Hopefully we can soon add the coffee makers and the Hospitality team to the list! If I have missed anyone out, then my apologies and thank you to you, too.

3 Administration and Finance

3.1 Secretary's Report

Since our APCM in 2020 we have had 4 PCC meetings. Minutes including APCM minutes are always in church after these meetings for anyone to read.

Amongst others we have discussed matters ecological including the provision of swift boxes; Planned Charitable Giving; Stewardship and fundraising; St. Andrew's part in the wider community and taking stock of where we are.

An audit was done on the church keys – not an easy job – and my thanks go to Charles Quartley for doing this as it was beyond my capabilities on the computer!

We now have 6 Church Wardens to lighten the load which seems to be working well and they have had separate meetings and my thanks go to them for all their hard work.

Finally my thanks go to the Rector and all PCC members and Wardens for their support.

3.2 PCC Financial Report

2021 was another challenging year as the ongoing pandemic continued to affect income from services, fees, collections etc. However, there was a marked increase in income from PCC fees and social events which helped to significantly reduce the General Fund deficit to £5k, the lowest for some time.

The main Fabric Fund expenditure was the new path along the wall separating the churchyard from the church hall, but this was partly offset by a grant from the council.

Despite the challenges, the PCC again made valuable gifts through the Annual Charitable Giving.

Once again, the investments held for both the General and Fabric Funds performed extremely well. The General investments increased in value by nearly £20k and the Fabric by nearly £6k. This is on top of the valuable income they provide to support cashflow.

The challenge for 2022 is to continue the target of at least removing the annual deficit on the General Fund. This remains a huge challenge, but given the plans of the PCC, and hopefully a full return to normality, it can be achieved.

Going Concern

Given that the annual deficit is reducing, the PCC has a program to increase income, and the value of investments is high, the PCC can once again confidently state that St. Andrew's represents a viable 'Going Concern' for the foreseeable future.

3.3 Planned Giving

For the past six years over forty members of our church community have given to our parish financially through the Parish Giving Scheme, donating over £180,000 to date plus gift aid.

Essentially, the scheme enables members to make contributions on a regular basis by Direct Debit, with gift aid being collected for taxpaying members (see example below). If desired, payments can be linked to inflation and can be reduced or cancelled should circumstances change. Members can remain anonymous and all costs are paid by the diocese.

There is considerable benefit in us not having to count cash in these still challenging times, and I would encourage everyone to make their donations in this manner if possible. By comparison, on a recent eucharist Sunday service, there was only £5 found on the plate at the end of the service.

In particular, there are some new church members who have joined us in recent years and they may not be aware of the scheme. I would be very happy to provide further details and a simple application form.

Looking ahead, I note our treasurer is now more optimistic about the future.

Finally, we would wish to thank everyone who has contributed to our parish finances, and please forgive me for repeating much of my article in the October/November edition of The Beacon magazine.

3.4 Electoral Roll

This year the revision of the electoral roll began on 26th February and was completed on 12th March.

Prior to this revision there were 85 people on the electoral roll.

Sadly since then three people have died and one person has moved to a new church.

We received two applications to join the roll but one of these people was already on the roll and so their application did not boost the numbers.

The number has therefore reduced to 82.

4 The buildings

4.1 Fabric

The fabric remains in good condition for the age of the building, with no unexpected problems.

The Working Party continues to meet on the first Saturday of each month and has gained new enthusiastic members. It has carried out many small repairs to the outside of the church on a regular basis, and maintained the rainwater systems, roofs and gutters as well as helping to look after the churchyard. We are grateful to all those who have taken part.

Unfortunately pigeons had damaged the wire netting inside the west belfry louvres, and were nesting inside, resulting in a build up of debris. The west louvre and netting have now been repaired and there has been an extensive clean-up of the belfry.

The Quinquennial Inspection of the church is due in 2023 and most of the requirements of the last one have been met, except for some paintwork needed on external doors to the turrets and roof void doors.

At some stage in the future, when funds allow, it would be good to re-decorate the inside of the church, which has not been done for over thirty years.

As a matter of interest our church architect has retired and we are in the process of appointing a new one, Mrs Alison Bunning. When visiting St. Andrew's to discuss whether she was willing to act for us, she said that the church gave her the immediate impression that it was well cared for and lovingly maintained.

4.2 Bells, tower, clock and ringers

The Ipplepen bellringers started back ringing in June 2021 following 15 months of no ringing due to COVID restrictions, it was lovely to hear the many comments from the villagers pleased to hear the Church bells ringing again.

Since then, we have continued our ringing, with the 12 ringers 'on the books' on each Sunday, together with our regular Wednesday evening practices.

In July 2021 our tower captain Colin Clark become very ill with meningitis and other complications and spent many weeks in hospital. Thankfully he came home and is slowly regaining his strength and we continue to wish him well with his recovery.

During 2021, we had a number of visiting teams, and we rang at 3 weddings and 3 funerals, sadly one of the funerals was for Ted Wonnacott who was a longstanding ringer at Ipplepen and is a real loss to our bellringing family.

In November we rang a half-muffled peal for Remembrance Sunday and had a full schedule of ringing over the Christmas period.

4.3 Churchyard

Our grateful thanks to John Lynch, who has again maintained the churchyard to a very high standard, and to the loyal band of volunteers who have helped trim the laurel hedge, pathways, and walls, and collect debris fallen from the trees.

4.4 Church hall

Although we continue living with "covid" still very much in our lives, what a joy it was on 17th May 2021 when we took Step 3 out of Government lockdown restrictions, and indoor classes started again. It was lovely to see all the regulars return with their fitness, pilates, taekwondo and yoga classes, plus Unity in Sound Community choir and the Brownies. These regular hirers use the hall between them five evenings a week, three afternoons a week and two mornings a week, so there is much activity going on in this well-loved hall.

The monthly "Church Lunch Club" is up and running again, and due to all the building works taking place at the Hub we have had the pleasure of hosting the "Memory Café" for many months in the Church hall too.

Of course, sadly we see funeral receptions at the hall as well, but as so many people have pointed out to me – the hall has a very friendly ambience, welcoming everyone – and every event therefore has a very personal feeling.

I think a lot of people are still a little afraid of going to big venues, and so already this year we have seen a rise in bookings for birthday parties, band practices and the like. At the same time, the hall has also been used by firms wanting a bigger space than their office to hold meetings in.

I am therefore confident that if the current trend continues, we will see a good year for hall bookings. This is very good news as the income we receive from hirers allows us to keep the hall in such a lovely condition, keeping it a very special place in a very special village. I would therefore ask anyone looking for a 'one off' booking, a Church event or coffee morning to book early so as to avoid disappointment.

5 Our Policies in Action

5.1 Health and Safety

Safety inspections have been carried out on Fire Extinguishers, Gas Boilers, the Chandelier Winch and Portable Appliances Testing (PAT) on all electrical appliances, both in the Church and Church Hall. Calibration and safety certificates have been issued following the inspections and testing.

We continue to follow Covid-19 guidance to ensure safety of the congregation by observing the wearing of masks and social distancing during all services; the use of hand sanitizers and sterilisation of surfaces following services.

5.2 Promoting a Safer Church Safeguarding

The action plan for the Parish Dashboard level one has been completed and approved by the Diocese. This work relates to the policy for safeguarding in line with national and local priorities and demonstrates how the policy is put into action and regularly reviewed.

The current work at level two must provide evidence that all church activities comply with detailed safeguarding guidance. We have already reviewed the safeguarding aspects of our pastoral care activities. Similarly, the development of our work on life events of weddings, funerals and baptisms, supported by the Diocese, has the promotion of a safer church at the heart of the progress we make.

There is now a mandatory requirement that those who work with children, young people and vulnerable adults must now renew their training certificate every three years. These courses can be done online and our process for updating has begun.

Caren in the office continues with the DBS checks which are now up to date. These are also required now every three years.

- 4. Topic for the future, to look at How to make our churches more welcoming and accessible to the wider community?
- 5. Challenges for 2022: Confidence booster vs. Caution (Anxiety) when the return to a more normal gathering, as post lockdown restrictions being eased.
- 6. Meetings ahead: 25th May, 2022 and 28th September, 2022.
